2. RHYTHM REGULARITY

ASSESS WHETHER THE RHYTHM IS REGULAR OR IRREGULAR BY MEASURING THE INTERVALS BETWEEN CONSECUTIVE R WAVES. CONSISTENT SPACING INDICATES A REGULAR RHYTHM, WHILE VARIABILITY SUGGESTS IRREGULARITY, WHICH COULD INDICATE CONDITIONS LIKE ATRIAL FIBRILLATION.

3. P WAVE ANALYSIS

THE P WAVE REPRESENTS ATRIAL DEPOLARIZATION. CHECK IF P WAVES ARE PRESENT BEFORE EVERY QRS COMPLEX AND WHETHER THEIR SHAPE AND DURATION ARE NORMAL. ABNORMALITIES HERE CAN INDICATE ATRIAL ENLARGEMENT OR ECTOPIC ATRIAL RHYTHMS.

4. PR INTERVAL

THIS INTERVAL REFLECTS THE TIME TAKEN FOR ELECTRICAL IMPULSES TO TRAVEL FROM THE ATRIA TO THE VENTRICLES. A NORMAL PR INTERVAL RANGES FROM 120 TO 200 MILLISECONDS. PROLONGED OR SHORTENED PR INTERVALS CAN IMPLY HEART BLOCK OR PRE-EXCITATION SYNDROMES.

5. QRS COMPLEX

THE QRS COMPLEX SHOWS VENTRICULAR DEPOLARIZATION. A NORMAL QRS DURATION IS LESS THAN 120 MILLISECONDS. WIDENED COMPLEXES MAY SUGGEST BUNDLE BRANCH BLOCKS OR VENTRICULAR RHYTHMS.

6. ST SEGMENT AND T WAVE

THE ST SEGMENT AND T WAVE REPRESENT VENTRICULAR REPOLARIZATION. ELEVATION OR DEPRESSION OF THE ST SEGMENT CAN INDICATE ISCHEMIA OR INFARCTION, AND T WAVE ABNORMALITIES MAY SIGNAL ELECTROLYTE DISTURBANCES OR MYOCARDIAL INJURY.
