1. STRATEGIC VISION AND MISSION

2. ENVIRONMENTAL SCANNING

THIS INVOLVES ANALYZING BOTH THE EXTERNAL AND INTERNAL ENVIRONMENTS THAT AFFECT AN ORGANIZATION'S STRATEGY. EXTERNAL ANALYSIS LOOKS AT FACTORS OUTSIDE THE COMPANY, SUCH AS MARKET TRENDS, COMPETITORS, AND REGULATORY CHANGES. INTERNAL ANALYSIS EXAMINES RESOURCES, CAPABILITIES, AND CORE COMPETENCIES. THE ABILITY TO PERFORM THESE ANALYSES OFTEN APPEARS ON STRATEGIC MANAGEMENT EXAMS THROUGH CASE STUDIES OR SCENARIO QUESTIONS.

3. PORTER'S FIVE FORCES MODEL

MICHAEL PORTER'S FIVE FORCES FRAMEWORK IS OFTEN A CORNERSTONE TOPIC. IT HELPS YOU UNDERSTAND THE COMPETITIVE FORCES SHAPING AN INDUSTRY:

1. THREAT OF NEW ENTRANTS
2. BARGAINING POWER OF SUPPLIERS
3. BARGAINING POWER OF BUYERS
4. THREAT OF SUBSTITUTE PRODUCTS OR SERVICES
5. INDUSTRY RIVALRY

KNOWING HOW TO APPLY THIS MODEL TO ASSESS INDUSTRY ATTRACTIVENESS IS A SKILL THAT'S FREQUENTLY TESTED.

4. SWOT ANALYSIS

SWOT ANALYSIS IS A STRAIGHTFORWARD YET POWERFUL TOOL TO EVALUATE AN ORGANIZATION'S INTERNAL STRENGTHS AND WEAKNESSES ALONGSIDE EXTERNAL OPPORTUNITIES AND THREATS. MANY EXAM QUESTIONS REQUIRE YOU TO IDENTIFY THESE FACTORS BASED ON A BUSINESS SCENARIO OR CASE STUDY, THEN RECOMMEND STRATEGIC ACTIONS ACCORDINGLY.

EFFECTIVE STUDY STRATEGIES FOR STRATEGIC MANAGEMENT EXAM 1

PREPARING FOR STRATEGIC MANAGEMENT EXAMS CAN FEEL OVERWHELMING, BUT A STRUCTURED APPROACH MAKES STUDYING MORE MANAGEABLE AND REWARDING.

PRACTICE WITH REAL-WORLD EXAMPLES

APPLYING THEORIES TO REAL COMPANIES HELPS SOLIDIFY YOUR KNOWLEDGE. LOOK AT BUSINESSES LIKE APPLE, STARBUCKS, OR TESLA AND ANALYZE THEIR STRATEGIES USING FRAMEWORKS COVERED IN YOUR COURSE. THIS METHOD NOT ONLY PREPARES YOU

FOR CASE-BASED QUESTIONS BUT ALSO MAKES THE LEARNING PROCESS MORE ENGAGING.

REVIEW PAST EXAMS AND QUIZZES

COMMON MISTAKES TO AVOID DURING STRATEGIC MANAGEMENT EXAM 1

OVERLOOKING DEFINITIONS

FAILING TO APPLY CONCEPTS

STRATEGIC MANAGEMENT EXAMS OFTEN EMPHASIZE APPLICATION RATHER THAN ROTE MEMORIZATION. BE PREPARED TO ANALYZE SCENARIOS AND RECOMMEND STRATEGIES RATHER THAN JUST RECALLING FACTS.

IGNORING QUESTION INSTRUCTIONS

CAREFULLY READ EACH QUESTION. SOMETIMES, YOU MAY BE ASKED TO IDENTIFY WEAKNESSES IN A STRATEGY RATHER THAN STRENGTHS, OR TO CHOOSE THE BEST ALTERNATIVE FROM MULTIPLE OPTIONS. MISUNDERSTANDING INSTRUCTIONS CAN COST VALUABLE POINTS.

FOR INSTANCE, STUDENTS MIGHT BE REQUIRED TO EVALUATE A COMPANY'S STRENGTHS, WEAKNESSES, OPPORTUNITIES, AND THREATS (SWOT), OR APPLY MICHAEL PORTER'S FIVE FORCES MODEL TO ASSESS INDUSTRY COMPETITIVENESS. THE EXAM ALSO INTRODUCES THE RESOURCE-BASED VIEW (RBV), WHICH ENCOURAGES LEARNERS TO CONSIDER A FIRM'S UNIQUE RESOURCES AND CAPABILITIES AS SOURCES OF COMPETITIVE ADVANTAGE.

KEY TOPICS COVERED IN STRATEGIC MANAGEMENT EXAM 1

PORTER'S FIVE FORCES

ANOTHER CORNERSTONE IS PORTER'S FIVE FORCES MODEL, WHICH EVALUATES INDUSTRY ATTRACTIVENESS BY ANALYZING COMPETITIVE RIVALRY, THREAT OF NEW ENTRANTS, BARGAINING POWER OF SUPPLIERS AND BUYERS, AND THE THREAT OF SUBSTITUTES. STRATEGIC MANAGEMENT EXAM 1 OFTEN INCLUDES QUESTIONS REQUIRING CANDIDATES TO ASSESS THESE FORCES TO ANTICIPATE PROFITABILITY AND SHAPE STRATEGIC MOVES.

RESOURCE-BASED VIEW (RBV)

THE RBV FRAMEWORK ENCOURAGES UNDERSTANDING HOW INTERNAL RESOURCES—TANGIBLE AND INTANGIBLE—CAN CREATE SUSTAINED COMPETITIVE ADVANTAGES. EXAM QUESTIONS MIGHT ASK CANDIDATES TO DIFFERENTIATE BETWEEN VALUABLE, RARE, INIMITABLE, AND NON-SUBSTITUTABLE (VRIN) RESOURCES, EMPHASIZING STRATEGIC RESOURCE MANAGEMENT.

PREPARATION STRATEGIES FOR STRATEGIC MANAGEMENT EXAM 1
