In addition to his contributions to early American religious and scientific thought, Kinnersley was the first Professor of English and Oratory at the University of Pennsylvania (then the Philadelphia College). As such he may have been the first person to hold the title Professor of English. This biography should be of importance to students of colonial culture, to Franklin students, and to those interested in the history of science or education in colonial America, as well as in the history of Philadelphia and the University of Pennsylvania.
