THIS SPECIFICITY MAKES IT PARTICULARLY VALUABLE FOR PRACTITIONERS SEEKING TO OPERATIONALIZE CLIENT GOALS INTO MEANINGFUL INTERVENTIONS.

FUTURE ITERATIONS OF THE OT PRACTICE FRAMEWORK ARE EXPECTED TO INCORPORATE GREATER EMPHASIS ON SOCIAL DETERMINANTS OF HEALTH, EQUITY, AND GLOBAL HEALTH PERSPECTIVES. ADDITIONALLY, THE INCORPORATION OF ARTIFICIAL INTELLIGENCE AND MACHINE LEARNING IN THERAPY PLANNING AND OUTCOME PREDICTION MAY BECOME MORE PROMINENT.

ONGOING RESEARCH AND PROFESSIONAL DISCOURSE WILL SHAPE THESE DEVELOPMENTS, ENSURING THAT THE FRAMEWORK REMAINS A LIVING DOCUMENT RESPONSIVE TO CHANGING SOCIETAL NEEDS AND ADVANCES IN SCIENCE.
