MOREOVER, BY FACILITATING PROPER TRAINING AND LICENSING, THE SPANISH CDL MANUAL CONTRIBUTES TO HIGHER STANDARDS OF PROFESSIONALISM AND SAFETY WITHIN THE INDUSTRY.

FUTURE DIRECTIONS FOR SPANISH CDL RESOURCES IN MINNESOTA

- **COMMUNITY OUTREACH:** COLLABORATING WITH HISPANIC ORGANIZATIONS AND DRIVING SCHOOLS TO PROMOTE AWARENESS AND UTILIZATION OF THE MANUAL.
- **MOBILE ACCESSIBILITY:** DEVELOPING APPS OR MOBILE-FRIENDLY VERSIONS OF THE MANUAL FOR ON-THE-GO STUDY.

SUCH INITIATIVES WOULD FURTHER DEMOCRATIZE ACCESS TO COMMERCIAL DRIVING CAREERS AND ENHANCE OVERALL ROAD SAFETY.
