IT TYPICALLY INCLUDES MULTIPLE-CHOICE QUESTIONS FOCUSING ON LOUISIANA-SPECIFIC TRAFFIC REGULATIONS, KEY ROAD SAFETY CONCEPTS, AND SCENARIOS YOU MIGHT ENCOUNTER ON THE ROAD. THE TEST IS DESIGNED TO ENSURE THAT NEW DRIVERS HAVE THE FOUNDATIONAL KNOWLEDGE NECESSARY TO DRIVE SAFELY.

THE ROAD SKILLS TEST

A: HEADLIGHTS MUST BE TURNED ON FROM SUNSET TO SUNRISE AND WHEN VISIBILITY IS LESS THAN 500 FEET DUE TO

WEATHER CONDITIONS.

- **Q:** WHAT IS THE LEGAL BLOOD ALCOHOL CONCENTRATION (BAC) LIMIT FOR DRIVERS OVER 21?

A: THE BAC LIMIT IS 0.08% FOR DRIVERS AGED 21 AND OLDER.

ROAD SIGN RECOGNITION

RECOGNIZING AND UNDERSTANDING ROAD SIGNS IS ESSENTIAL NOT ONLY FOR PASSING THE TEST BUT ALSO FOR SAFETY ON THE ROADS.

- **Q:** WHAT DOES A YELLOW DIAMOND-SHAPED SIGN WITH A BLACK PLUS SIGN INDICATE?

A: IT WARNS OF AN UPCOMING INTERSECTION.

- **Q:** WHAT SHOULD YOU DO WHEN YOU SEE A “YIELD” SIGN?

A: SLOW DOWN, PREPARE TO STOP IF NECESSARY, AND GIVE THE RIGHT OF WAY TO TRAFFIC ON THE INTERSECTING ROAD.

TIPS TO PREPARE FOR THE LOUISIANA DRIVING KNOWLEDGE TEST

UNDERSTAND LOUISIANA-SPECIFIC DRIVING RULES

- KEEP BOTH HANDS ON THE WHEEL AND MAINTAIN PROPER POSTURE.
- AVOID UNNECESSARY MOVEMENTS OR DISTRACTIONS DURING THE TEST.
