WHILE CMS-HCC PRIMARILY FOCUSES ON DIAGNOSIS CODES TO CALCULATE RISK SCORES FOR MEDICARE ADVANTAGE PLANS, WELLCARE'S METHODOLOGY EMPHASIZES A MORE COMPREHENSIVE BIOPSYCHOSOCIAL MODEL.
